THE MOST IMPACTFUL CONCLUSIONS WILL CLEARLY ARTICULATE THE GAPS, INCONSISTENCIES, OR UNANSWERED QUESTIONS IDENTIFIED WITHIN THE EXISTING RESEARCH. THIS IS THE PIVOTAL MOMENT WHERE YOU BRIDGE THE LITERATURE REVIEW TO YOUR OWN STUDY, EXPLAINING HOW YOUR PROPOSED RESEARCH AIMS TO FILL THESE SPECIFIC GAPS, ADDRESS THESE QUESTIONS, OR OFFER A NEW PERSPECTIVE. A WELL-CRAFTED CONCLUSION NOT ONLY SUMMARIZES BUT ALSO SETS A COMPELLING STAGE FOR YOUR UNIQUE CONTRIBUTION.

TIPS FOR ENHANCING YOUR LITERATURE REVIEW STRUCTURE

Q: CAN I COMBINE DIFFERENT ORGANIZATIONAL APPROACHES IN MY LITERATURE REVIEW STRUCTURE?
