UNDERSTANDING THE LEGALITY OF SCANNING TEXTBOOKS

- **INSTITUTIONAL POLICIES:** SCHOOLS AND EDUCATIONAL INSTITUTIONS MAY HAVE POLICIES IN PLACE REGARDING THE REPRODUCTION OF MATERIALS. TEACHERS SHOULD BE FAMILIAR WITH THESE RULES TO ENSURE COMPLIANCE.

IT IS CRUCIAL FOR TEACHERS TO BE AWARE OF THESE LEGAL PARAMETERS TO PROTECT THEMSELVES AND THEIR INSTITUTIONS FROM POTENTIAL LEGAL ISSUES.

LIBRARY RESOURCES

MANY EDUCATIONAL INSTITUTIONS PROVIDE ACCESS TO DIGITAL LIBRARIES WHERE STUDENTS CAN FIND TEXTBOOKS AND OTHER RESOURCES WITHOUT THE NEED FOR SCANNING. THIS OPTION CAN ALLEVIATE CONCERNS OVER LEGALITY AND QUALITY.
